

IN CONSIDERATION OF **MARITIME NINJA WARRIOR** allowing the participant described below to participate in ninja warrior training or activities, the participant agrees as follows on behalf of themselves, their spouse, children, parents, heirs, assigns, personal representatives and estate:

1. I acknowledge that my participation in **MARITIME NINJA WARRIOR** activities entails known and unanticipated risks that could result in physical or emotional injury, paralysis, death, or damage to myself, to property, or to third parties. I understand that such risks simply cannot be eliminated without jeopardizing the essential qualities of the activity. The risks include, among other things: cuts and bruises; falling off of equipment; muscle and joint sprains and strains; broken wrists, ankles and legs;

My participation in this activity is purely voluntary and I elect to participate in spite of the risks.

2. If I and/or my child/ward are injured, I acknowledge that I and/or my child/ward may require medical assistance, which I acknowledge will be at my own expense or the expense of my personal insurer(s). I hereby represent/affirm that I have adequate insurance to provide coverage for such medical expenses. I understand and agree that **MARITIME NINJA WARRIOR** will not pay for any cost or expenses incurred by me if I and/or my child/ward are injured.

3. I hereby voluntarily release, forever discharge, and agree to indemnify and hold harmless **MARITIME NINJA WARRIOR** and to waive any and all claims, demands, or causes of action, that I have or may have in the future against **MARITIME NINJA WARRIOR** and to release **MARITIME NINJA WARRIOR** from any and all liability for any loss, damage, expense or injury including death that I may suffer or that my family, heirs, assigns, personal representatives and estate may suffer as a result of my participating in **MARITIME NINJA WARRIOR** training and activities DUE TO ANY CAUSE WHATSOEVER, INCLUDING NEGLIGENCE, BREACH OF CONTRACT, OR BREACH OF ANY STATUTORY OR OTHER DUTY OF CARE.

4. I agree to hold harmless and indemnify **MARITIME NINJA WARRIOR** from any and all liability for any property damage or personal injury to any third party resulting from my participation in ninja training or activities. Furthermore, should **MARITIME NINJA WARRIOR** or anyone acting on its behalf be required to incur legal fees and cost to enforce this agreement, I agree to indemnify and hold **MARITIME NINJA WARRIOR** from all such fees and costs.

5. I acknowledge that I have read the rules governing my participation and/or my child/ward's participation in any activity at **MARITIME NINJA WARRIOR**.

I further grant **MARITIME NINJA WARRIOR** the right to photograph, videotape and/or record me and/or my child/ward and to use my or my child/ward's name, face, likeness, voice and appearance in connection with exhibitions, publicity, advertising and promotional materials without reservation, limitation or compensation.
